### 2. Hazards identification

**2.1 Classification of the substance or mixture**

Inorganic glass is not classified as dangerous.

**2.2 Label elements**

No labeling required.

**2.3 Other hazards**

This glass is not dangerous at normal usage.  
 Improper handling by heating over 150°C or contact with strong acids and basic compounds can result in the formation of toxic compounds. Temperatures above 500°C on air can cause chemical decomposition resulting in the formation of toxic compounds Sb<sub>2</sub>O<sub>3</sub>, SeO<sub>2</sub>. Strong acids or bases may cause the formation of soluble Antimony and Selenium compounds.  
 Grinding debris and other waste of glass must be disposed consistent with applicable regulations. Processing of glass, damage or breakage can result in sharp edges. This may cause cuts. Processing of glass can result in glass dust. Acute effects: Respiratory irritation. Chronic effects: Possible pneumoconiosis effects.

### **3. Composition/information on ingredients**

#### **3.1 Substances**

As the substance glass is not included in the candidate list of substances of very high concern, currently there are no information duties according to article 33 of REACH. However for the production of glass we may use substances, which are on the candidate list and had been included in Annex XIV of the REACH regulation or could be included in future. These powdery substances are not present as such in the final glass; they are fully integrated into the glass matrix through the melting process. Thus they lose their original characteristics. **10. Stability and Reactivity****10.1 Reactivity**

Glass is a stable material. Glass is inert to many chemicals, but may react to hot, strong alkaline solutions and with hydrofluoric, fluorosilicic and phosphoric acids. When heated to temperatures above the melting point, metal oxide fumes may be emitted.

This glass decomposes at temperatures > 500 °C in air and/or oxidizing atmospheres. The decomposition products include Selenium-Oxide (SeO<sub>2</sub>) and Antimony Oxide (Sb<sub>2</sub>O<sub>3</sub>). These products are toxic.
